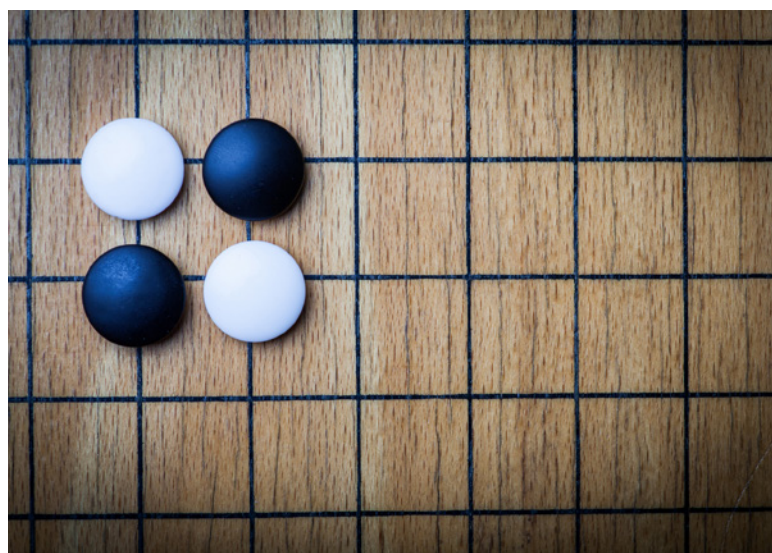

- Ensure confidentiality
- Tailor an outcome which can be embodied in a legally enforceable settlement agreement, or a court order
